

## Who We Are

The Ninilchik Village Tribe is made up of approximately 800 members who trace their roots to the Ninilchik tribal lands as well as other Bureau of Indian Affairs-recognized Alaska Natives and American Indians who have settled in the tribal boundaries and have applied, and been accepted, for membership. The governing body of the Ninilchik Village Tribe, the Ninilchik Traditional Council, is presided over by a board of directors of 5 council members elected by the voting tribal membership to 3 year terms. The council directs executive staff using the Ninilchik Village Tribe's Organic Documents, which are set by the voting tribal membership to exercise tribal operations and tribal sovereignty, as guidelines.



## Executive Director's Address

Fall is upon us and I hope everyone had a great fishing season and somehow managed to get a moose. As we transition from fishing to hunting, I want to take a moment to thank Shelley Self for administering the educational fishery. She did a wonderful job and deserves commendation for keeping everyone signed up and ready for their day. While we had to let a few kings go, which made me tear up a little, well maybe a lot, the season was fruitful in other respects. On a positive note, we managed to get our entire allotment of silvers in Ninilchik as well as in Kasilof, minus one.

On the health front, I am excited to say that we have made great progress on the doctor search. As you are aware, we have been recruiting for a doctor for some time now. Our efforts seem to have paid off. A tentative agreement has been reached, and barring any unforeseen credentialing issues, we hope to have this doctor working at least three (3) days per week towards the end of November.

Several representatives from the Tribe participated in Tamamta Katurlluta- A Gathering of Native Tradition. This was held August 30<sup>th</sup>-September 1<sup>st</sup> and it is a collaboration with the Pratt Museum, Native villages, and tribes in the region. This event includes dancers, food, drummers, and the sharing of cultural heritage. I was honored to attend the Evening of Culture and Dance, as well as participate in the Talking Circle supported by the Alaska Humanities Forum, along with the Pratt Museum. I want to express my heartfelt thanks to the Pratt Museum for all the wonderful work they do.

The 2013 annual election is coming up and I encourage people to vote and participate in the annual meeting, which will be held Saturday, November 16<sup>th</sup>, 2013 at the NTC subsistence building. On this note, I want to remind the membership of the additional constitutional amendment # F that will be on the ballot this year, along with reiterating some of my remarks from the last newsletter.

The NTC constitution requires the tribe to waive its sovereign immunity in order to apply for or receive funding from the State of Alaska. Tribes enjoy sovereign immunity, which holds that they cannot be held liable, or be sued in court for tort actions. The state views this as troublesome in order to carry out funding accords with tribes, especially if they have no recourse in the execution of a grant or contract. As part of the state funding application process, a limited waiver of our immunity must be completed in order to even submit an application for funding. This creates a laborious and unreasonable demand on our end. This is due to the fact that the tribal constitution requires that any waiver of our immunity must be done by a vote of the membership. All tribal elections are conducted by mail and we would have to implement a special election for every grant, funding agreement, or receipt of monies from the state.

This leads me to a positive resolution through a change in our constitution. The proposed constitutional amendment would add two sentences under Article VI, Section 2. General that would state: "However, the NTC shall be authorized to waive the tribe's sovereign immunity specifically as it pertains to entering into, executing, and carrying out grant, contract, or funding accords with the State of Alaska.

This limited waiver shall be duly approved by the NTC through an explicit resolution, which may waive the tribe's sovereign immunity from suit with respect to claims by the state arising out of the activities related to the particular agreement." Please note that the NTC refers to the board of directors.

This implements a nice balance for operation of programs and services, yet retains the waiver of immunity to the membership for all other matters except state funding requests, accords, grants, and contracts. At this time we do not receive state monies, except those passed through another organization where a waiver is not required. In addition, we have recently felt that our potential to expand services has been stymied by the need for a waiver, in which it takes months to conduct an election. I encourage your support on this issue and please contact me if you have any questions or concerns on this matter.

On the council news front, the board held their last regular meeting on September 12<sup>th</sup>, 2013. The council discussed and heard reports from program directors and adopted a resolution suspending the election of judges again for this year, the same as they did last year. Until the tribal court is fully functional it is unnecessary to continue administrative work to elect them every year. Furthermore, they approved a proposal to upgrade the clinical network equipment and discussed the educational fishery, transit facility, and tribal boundary issues. The next regular meeting was set for Thursday, October 10<sup>th</sup>, 2013 at 10:00 a.m.

As always, please feel free to stop in for some coffee. I also encourage you to attend the regular council meetings, thereby getting involved with ongoing activities and events here at the Tribe.

## Election Notice



### **Notice of the 2013 NTC Annual Election November 11th**

The 2013 NTC Annual Election date has been set as November 11, 2013 (per the Constitution of the Ninilchik Tribe, this is the deadline for ballots to be received, and no late ballots can be accepted). The purpose of this election is to elect two (2) Council members for three-year terms and to vote on a Constitutional Amendment issue. Resolution # 2013-12 passed at the September 12, 2013 NTC Council meeting, which suspended electing tribal court judges for the 2013 annual election. NTC realizes that the Tribal Court does not currently have a working and functioning purpose at this time, as it is in the early developmental stages. Therefore, the process of continuing to elect judges annually is not necessary and warrants suspension until further notice.

#### Council Seat

Any NTC registered voter, who resides within the Ninilchik Traditional Council's Tribal Boundaries, may run for a Council seat, by simply filling out a Declaration of Candidacy Form. Please keep in mind that the Declaration of Candidacy forms must be received in the Ninilchik Traditional Council's Tribal Services Office no later than October 17, 2013.

Any new candidate running for the Board, or any previous Board member seeking re-election, shall be deemed unqualified if found to be, in any capacity, an employee of NTC, either inactive, temporary or permanent, full or part time. However, no voter seeking election shall be placed upon the ballot if such voter has been convicted of or pled guilty or no contest to a felony offense involving dishonesty or moral turpitude within five (5) years of the date of the election; or has been found guilty of, or entered a plea of nolo contendere or guilty to, any felonious offense or any of 2 or more misdemeanor offenses under Federal, State, or tribal law involving crimes of violence; sexual assault, molestation, exploitation, contact or prostitution; crimes against persons; or offenses committed against children. Furthermore, no voter seeking election shall be placed upon the ballot if such voter has been previously recalled by election from the NTC Board within five (5) years of the date of the election. In addition, a successful candidate must provide the results of a drug and alcohol test in the same manner as that required to be submitted by tribal employees before being installed into office. All Council members are subject to background investigation and Drug & Alcohol testing in accordance with the Ninilchik Traditional Council's Anti Drug and Alcohol Plan, in order to comply with appropriate Federal requirements. These are required because the Ninilchik Traditional Council administers programs with federal money, which mandates that the Tribe comply with mandatory background checks and drug-free certifications. Council members will, at times, have control or work directly with children and child custody issues. As a result, the Indian Child Welfare Act program, that the Tribe administers, requires copies of background checks.

## Election Notice *Continued*

### Proposed Constitutional Amendment F:

The Ninilchik Village Tribe contracts and receives grants from several federal sources to administer various health, social services, education, housing, environmental, and resource management programs. The United States federal government does not require waivers of sovereign immunity in order to execute grant and contract funding, however, the State of Alaska requires a waiver of the tribes' immunity in order to apply for grant and contract funding. The Ninilchik Village Tribe's constitution currently requires the membership to waive the sovereign immunity through a specific mail in vote for each issue necessary to waive that immunity. NTC desires to place the issue of amending the constitution on the November 11, 2013 ballot in order to allow the NTC to waive immunity, which will be limited to State of Alaska funding requests and accords, thereby retaining the waiver of immunity to the membership for all other matters.

*Shall the Tribe amend Article VI- Powers of the Ninilchik Traditional Council, Section 2 - General, of the Ninilchik Tribal Constitution to allow the NTC to waive immunity, which will be limited to State of Alaska funding requests and accords, thereby retaining the waiver of immunity to the membership for all other matters., (additions indicated by underlining):*

#### "Section 2: General"

The NTC shall have all of the appropriate powers necessary to implement specific provisions of this Constitution and to effectively govern the affairs of the tribe. All other powers not referred to in this constitution, including the waiver of the tribe's sovereign immunity to unconsented suit, are reserved to the general membership and may be exercised through initiative, referendum or amendment to this constitution. However, the NTC shall be authorized to waive the tribe's sovereign immunity specifically as it pertains to entering into, executing, and carrying out grant, contract, or funding accords with the State of Alaska. This limited waiver shall be duly approved by the NTC through an explicit resolution, which may waive the tribe's sovereign immunity from suit with respect to claims by the state arising out of the activities related to the particular agreement."

The 2013 NTC election is conducted by mail and there will be no polling place open for in-person voting on Election Day. Ballots will be mailed on October 22, 2013. Any registered voter who does not receive a ballot by mail may request such a ballot in person, by phone, telefax, or mail at the Ninilchik Traditional Council's Tribal Services Office.

All ballots must be received by or on November 11, 2013


You must mail your ballot in plenty of time to ensure that it is received in the post office by or on Election Day. There is no postmarking deadline, ballots must be received in the Election Committee's Ninilchik post office by or on Election Day. **Please note, November 11, 2013 is Veterans Day and the US Post Office will be closed. Please make sure you mail your ballot in plenty of time to arrive in the Post Office box no later than November 9, 2013.**

## Tribal Services: Social Services

### *Mandatory Reporters*

The State of Alaska requires certain individuals (including health care providers, teachers and administrators, police officers, institutional administrative officers, day care or child care providers, paid employees of domestic violence intervention or prevention programs, paid employees of drug and/or alcohol treatment or rehabilitation programs, members of special teams that review deaths of children, and athletic coaches) who in the course of performing their jobs know or have reasonable cause to suspect a child is being abused or neglected to report the abuse to the Department of Health and Social Services. The law also provides that any other person who knows or has reasonable cause to suspect child abuse or neglect may report the harm to the child to the Department of Health and Social Services. Mandatory reporting is also a responsibility for several staff members of NTC.

If there is an emergency situation and the Department of Health and Social Services cannot be reached, the statute allows a person to make the report to a law enforcement officer who is then required to take action and notify the Department of Health and Social Services as soon as possible. The statute defines child abuse as physical injury, neglect, mental injury, sexual abuse, sexual exploitation or other maltreatment of a child that harm the health or welfare of the child.

### *Child Care*

Child care is essential for working parents and parents engaged in higher education. Child care improves the lives of families and promotes economic success of our Tribe. First, child care allows parents to go to work every day. As our economy continues to recover from the deepest recession in decades, it is critical for families to have access to quality care so that parents have the peace of mind to seek and retain employment that will fuel the recovery. But due to the high cost of care, many low-income families cannot afford to pay for child care by themselves. Child care subsidies allow these families to access care that they could not otherwise afford. Research shows that parents who receive subsidies to help them pay for child care are more likely to work, work more hours, maintain employment, and earn more (Schaefer, Kreader, and Collins, 2006).






